a No person shall light, ignite, or start to allow or cause to be lighted, ignited, or started, a fire of any kind whatsoever in the open air without the consent or assistance of the Paradise Hill Fire Department.

- a shall not be required to light, ignite, or start or allow or cause to be lighted, ignited, or started, a fire in a fire pit, fire ring, fire box, or a similar device designed for cooking or recreational use, provided that meets the following Notwithstanding Subsection 1), consent or assistance of the Department criteria: that it

- C No person shall light a fire in a receptacle that meets the criteria set out in Section 4) a) if a fire ban has been issued pursuant to Section 7) a).
- 5 If smoke from a fire causes an unreasonable interference with the use and enjoyment of another person's property, the fire must be extinguished immediately.

L Fire Bans

- a) The Council, the administrator, or the Fire Chief may prohibit all outdoor fires within the municipality if the wind or other conditions are not conducive to fire safety.
- 9 Notice of a fire ban shall be posted in the Village Office and on the Village
- C A fire ban issued pursuant to Section 7) a) shall remain in effect until the Council, administrator, or the Fire Chief issues an end to the fire ban.
- 9 A fire ban issued pursuant to section , , , or similar device designed for fires started in a fire pit, fire box, fire ring, or similar device designed for recreational use. fire ban issued pursuant to section 7) a) shall apply to all fires, including
- 8 Any fire which is deemed he the Fire Chief or a Member which is deemed hazardous, may be extinguished or removed by order of
- 9 Nothing contained in this bylaw shall relieve any person from complying with the provisions of *The Clean Air Act* and the regulations passed pursuant thereto.

10) Exemptions to Burning Regulations

Notwithstanding any other provision of this bylaw, the Fire Chief or any other member designated by the Fire Chief may burn buildings, structures, or other materials for the purpose of training its personnel in structural firefighting methods, fire investigation procedures, for the purpose of elimination of hazards or any other municipal purposes

11) Contravention of the Bylaw

- a Every person who contravenes any provision of this Bylaw is guilty of offence and liable on summary conviction to a fine of \$1000.00. an
- 9 for the purpose of this Bylaw. Where the Designated Officer believes that a person has contravened any provision of this Bylaw, he may serve upon such person a Bylaw Violation Notice as provided by this section either personally or by mailing or leaving same at his last known address and such service shall be adequate
- C
- Such notice shall be deemed to have been served:

 i) on the expiration of three days after it is posted, if the notice is mailed;
- €E on the day of actual delivery, if the notice is served personally; or on the business day following the transmission, if given by facsimile.
- Notice" Schedule "A" to this bylaw is the form to be used for a "Bylaw Violation given under Section 8 a).

- e) The person to whom a Bylaw Violation Notice was issued may make a voluntary payment of \$500.00, deposited with the Administrator of the Municipality, within twenty 20 days from the issue of the Bylaw Violation Notice. Upon payment of said voluntary payment, the person shall not be liable for prosecution for the contravention in respect of which the ticket was issued
- J Where any person contravenes the same provision of this Bylaw two or more times within one twelve month period, the specified voluntary payment payable in respect of the second or subsequent contravention is double the voluntary payment for the first offense.
